1. Call To Order and Pledge of Allegiance

Chair Maggiore called the meeting to order at 7:00 PM. Those in attendance were Selectman Miller, Selectman Stanton and Town Administrator Apple.

Chair Maggiore led the Pledge of Allegiance.

Chair Maggiore stated he would be moving agenda item 6.1 up on the agenda, and welcomed new employee, Officer Paul Yanakopulos to the town.

Chief Maddocks also welcomed Officer Yanakopulos.

Officer Yanakopulos thanked the Select Board for the opportunity to serve the community.

2. First Public Comment Session

Public Comment is an opportunity for residents to ask questions, request information and make comments on issues facing the Town. Individuals ordinarily will be given not more than three (3) minutes to speak, and people who have already spoken will be asked to wait until everyone has had the chance to speak once. The total time devoted to this agenda item is fifteen (15) minutes. Individuals who are not able to speak during the First Public Comment Session will be given first opportunity to speak during the Second Public Comment Session at the end of the Meeting.

George Chauncey, Hobbs Road addressed the Select Board and stated his displeasure at comments made toward him and others that put forth the petitioned warrant article at the last meeting by a member of the public. He stated people are allowed to have their opinion, but there is no need to “name call.”

Mr. Chauncey stated the people of North Hampton want a choice; not the same plan year after year.
