Other ideas for educational opportunities included hosting speakers to discuss topics such as best management practices, composting, protecting your landscape from wildlife and protecting livestock from predators. Some of these could also be used as future newsletter topics. The idea was also discussed of putting a blurb in the town Friday Folder to get feedback on what topics the public may be interested in.

4b. <u>North Hampton Little Boars Head Coastal Hazards Master Plan Chapter Steering Committee</u>: The project website is live and public information sessions are in progress. The committee will be meeting one more time in February to discuss the results from the public information sessions and finalize the draft of the master plan chapter.
