



Question 1: How many years have you lived in North Hampton?




Question 2: What do you like MOST about living in North Hampton?




Question 3: Which of the following categories best describes your living situation?



Question 4: Which of the following categories best describes your employment situation?




Question 5: How many miles does the primary income-earner in your household travel to work (one way)?



Question 6: What roads do members of your houshold who are employed outside the home take to work?




Question 7: In what town or city does the primary income-earner in your household work?




Survey Highlights: Planning Zoning

- Continued Interest in pursuing senior or elderly housing. Several comments by survey takers expressing a wish to stay in the community when they can no longer care for their own homes.
- A strong desire to limit fast restaurants, while receptive to full service restaurants.
- A desire to see cross-walks placed across major intersections.
- More support for sidewalks than against sidewalks, though opinions are strong on both sides of the topic.
- Strong support for environmental protection, including aquifer protection, open space, wetland preservation, and stonewall preservation.
- Lack of support for approving additional manufactured housing parks.
- Strong support for locally owned businesses!




Survey Highlights: Quality of Life

- Concern over motorcycle noise and vehicle speeding, plus the use of secondary roads to circumvent primary roads, each of which were highlighted frequently in the comment sections.
- Concern over the appearance of route one, and frustration over properties which appear to be junk yards, both on route one and among residential roads.
- Strong support for protected open spaces!
- A desire for more parking at North Hampton Beach.
- Support for Bicycle paths along roads and off-road.
- Concern over road side litter.


Survey Highlights: Town Services

- Concern over the fairness involved with tax assessment and property taxes in general. "Too many drive by assessments"!
- Concern over code enforcement, specifically
 - Favoritism, randomness, and the continuation of non-conforming properties which are allowed to continue.
 - Junkyards continue to be tolerated.
 - Some indication that zoning is too cumbersome.
- Concern over the cost of supporting a public school district.
- Concern over the cost of the Police and Fire Departments.


Survey Highlights: Town Services

- Limited support currently exist for the expansion of Police station, Fire station, the school, or the Library, though an expansion of the library appears more palatable than an entirely new building.
- Residents are willing or very willing to accept current service levels and existing town facilities, if it means their taxes will stay nearly the same.
- Strong satisfaction with our town services.
- A general desire for more recreation facilities, but defining precisely what the public wants in recreation facilities requires further study.


Question 10: How satisfied are you with the QUALITY of each of the following town services?






Question 11 A-G: Please indicate your opinion of each of the following facilities, services, or regulations.




Question 11 H-M: Please indicate your opinion of each of the following facilities, services, or regulations.




Question 11 N-T: Please indicate your opinion of each of the following facilities, services or regulations.




Question 11 U-Z: Please indicate your opinion of each of the following facilities, services or regulations.




Question 12: To limit tax increases, how wiling are you to accept current levels of Town services and facilities?




82% of Respondents indicated willingness to accept current levels in order to control taxes.
