- A. NH DES Expedited Minimum Impact Wetlands Permit Application: 8 Dancer's Image Lane, Tax Map 6, Lot 2-2, North Hampton, NH.** On behalf of Michael A. Falzone and Laura J. Harper Civil Works New England has submitted plans to to construct a 152 S.F. pool and an 822 S.F. pool deck. The pool deck will have 3 sets of stairs providing access to the existing deck and lawn. A landscaped area is proposed along the east and south side of the pool deck. The project is located in the 100' Tidal buffer zone and partially in the natural woodland buffer. The project does not impact the FEMA flood zone AE (Elev.=9') or the freshwater wetlands located on-site. Town of North Hampton, tax card, indicates the primary structure was built prior in 1999.
