- A. NH DES Expedited Minimum Impact Wetlands Permit Application:** The New Hampshire Department of Transportation proposes to replace a 12" Corrugated Metal Pipe (CMP) culvert with a 12" Reinforced Concrete Pipe (RCP) and install a new precast concrete outlet headwall. The existing culvert is 150' long. The replacement culvert will be shortened to 50' in order to make maintenance of the outlet accessible and feasible and significantly minimize disturbance to the well-established marsh. A 10' by 10' x 2' stone lined catchment or apron, permanent impact, will be constructed at the outlet of the culvert. Erosion control measures will be placed prior to work starting.
