Upon review of the deed and discussion of the property and the Commission discussed the ecological significance of protecting this land, its close proximity to other conservation land, and that acquisition of this parcel will further protect Little River.

Kathy Grant *motioned, Seconded by* **Lauri Etela** to authorize the Chair and Andy Vorkink to pursue the acquisition of this land. In addition, the Commission authorized expenditures of \$5000 for legal fees and up and expenditures up to \$5000 for closing costs. The Commission authorized the Chair to engage Michele Peckham to prepare legal documents consistent with recent conservation provisions and to prepare the legal documents pertaining to the acquisition of this parcel. The parcel has an appraised value of \$19.500. **The motion passed.**
