- 2.4 The members of the subcommittee have agreed to meet on Thursday, May 31, 2018 at 7pm at Amanda's house to begin the process of filling out forms.
- 2.5 Meredith volunteered to get started ahead of time on filling out the forms she received from her father regarding the establishment of the 501C.
- 2.6 The group discussed that if we needed to determine a Board of Directors, the active members of the committee would be listed. Paige made a motion, Ronni seconded. Unanimously accepted.
- 2.7 Additionally, the group unanimously accepted that Pat would be listed as President, Casey would be Vice-President, Michael would be Treasurer and Marlane would be Secretary.
- 3. Jalisa shared the plan for the Dog Park Facebook page and made a motion to publish/activate it. Casey seconded. Unanimously accepted.
 - 3.1 Jalisa made a motion to make herself, Casey, Amanda and Paige administrators of the Facebook page. Unanimously accepted. These individuals will be responsible for scheduling posts and keeping up with the Dog Park Facebook page.

This could talk about their favorite activities or toys, their rescue/forever home story (if they are a rescue), or any quirky characteristics they have.  - 3.3 Additionally, Casey told the group that if they have any suggestions/recommendations of things other committee members want to see posted/featured on the Facebook page they can send it to the dog park email address and she will share it with the other Facebook page administrators to review.
- 4. Pat shared that she is going to hold off on our efforts to be included in the Friday Folder until a later date when we have a plot of land confirmed.
- 5. Paige shared topography maps of the potential site (behind the community gardens)
 - 5.1 Paige then showed several potential setups and plans of how we could use the land
