Create 2020-2021 Budget Committee Schedule

Chairman Pinette gave everyone last year's meeting schedule and said the schedule for this year would pretty much mirror the same dates. Vice-Chair Goode said the August 17th date for the Budget Committee/Little Boar's Head Joint Meeting was fine with him. Chairman Pinette said the Budget Committee agreed to change the meeting time to 6:00 pm, and said he would coordinate with Interim Town Administrator Tully to make sure Monday's were blocked off. Ms. Le said Wednesdays were not good for her due to House Sessions in Concord.

Budget Committee Meeting May 18, 2020

Mr. Ferraro asked who would present the Economic Review this year as James Sununu is no longer on the Committee. Chairman Pinette said he spoke to Mr. Sununu who declined, but Shep Kroner may be interested in making that presentation. Mr. Ferraro said budget presentations alternated every year, and last year the Town went first and asked if the School would go first this year; Chairman Pinette agreed the School would go first. Mr. Ferraro also asked that more time be allowed for Budget Committee review after distribution of budget books.

Motion: To accept the offer of Shep Kroner to do the Economic Review Presentation this fall.

<u>Discussion</u>: Mr. Delano said she was definitely interested in the position.
