Review Department of Public Works capital projects FY24-29

Public Works Director Hubbard reviewed his department's capital projects for FY24-29 which includes:

F600 Ford Medium Duty Dump Truck for 2024;

Installation and overlay of approximately 2.0 miles of roadway for 2024;

Total Reconstruction of approximately .3 miles of roadway, reclamation of .5 miles of roadway and overlay to approximately 1 mile of roadway for 2025;

Reclamation of approximately .5 miles of roadway, installation of asphalt shim and overlay to approximately 2 miles of roadway for 2026;

Replacement of F550 Medium Duty Dump Truck for 2027;

Installation of asphalt and overlay to approximately 3 miles of roadway for 2027;

Installation of asphalt, shim and overlay to approximately 2.3 miles of roadway for 2028;

Installation of asphalt, shim and overlay to approximately 3 miles of roadway for 2029
