16	8.1 Presentation of "524" Award
17	Police Chief Mone said we are here tonight to present the 6 th Annual Officer Peter Cormier 524 Memorial
18	Award established in 2017 in his memory and honor. Officer Peter Cormier passed away unexpectedly in
19	2015 at the age of 46 and was an 18-year veteran of the North Hampton Police Department at that time.
20	The award is presented this year to Lieutenant Jim Russell; presented to Lt. Russell by Jamie Cormier,
21	brother of Peter Cormier.

23	Lieutenant Russell thanked everyone; he said his role is to promote a team atmosphere, provide guidance,
24	and get work done. He said he hoped he could leave a legacy like Pete's when he is gone and was happy
25	to have been able to work with him.

Correspondence

Correspondence from Comcast: Chairman Sununu read the correspondence from Jay Somers of Comcast in full, dated November 18, 2022, notifying North Hampton that starting December 20, 2022 prices for certain services and fees would be increasing including Broadcast TV and Regional Sports Network fees.

Committee Updates

Vice-Chair Maggiore said neither the Heritage Commission nor the Water Commission had met.

Chairman Sununu said *Rails to Trails Committee* is working on a meeting for early December; *Budget Committee* has met several times: did a first review of the Town, Library, and School Budgets and all have a second review coming up over next few weeks. Next Town/Library review is December 5, 2022 with second School Review 2 weeks later.

Report of the Town Administrator

<u>Period November 15 – November 25, 2022</u>: Finance at 61% of Budget remaining with 32 weeks left in fiscal year; Police took delivery of new 2022 Cruiser to be fully outfitted by January; Fire Department also took delivery of Utility Truck currently being outfitted; saleable parts of Town Office Building being auctioned; Recreation: Santa's breakfast December 10; Highway: all trucks in service, fall cleanup in progress, preparing for winter; PFAS may have to wait for spring; Seacoast Private Well Initiative date set for January 11, 2023 at Exeter High School to discuss contaminates and hand out sampling.

8.2 Town Office Building Update

Marc Jobin, Builder's Representative, said Town Offices are going well; Addition framed and weathertight, roofing done; inside insulated and framed out. Main building drywall completed, started painting; installation of acoustical tile for ceilings next; flooring in next couple of weeks. On track to finish by Christmas, then shifting attention to Safety Complex in January. He said a few things have cropped up but have been taken care of; one window for Addition on back-order; working with Eversource on relocating some power; no issues slowing construction.

Town Administrator Tully said electricians will be putting in lighting on Thursday and Friday. Mr. Jobin said demo of existing building will be after the first of the year with subsurface investigation being done tomorrow.

Police Chief Mone said the Department has had a Prosecutor, John Ventura, since 2014; our needs have increased and Mr. Ventura's time has decreased. In the contract before you this attorney will do some extra things as well as prosecute all our cases in Court, above that through Rockingham County Attorney. The Department has had 134 District Court cases so far this year, 41 are DWI. The new Prosecutor Contract will be doing all the same things as well Juvenile Hearings; the attorney comes with a victim's advocate and also covers trainings once/month as well as providing legal updates.
