2013 Church St Main - replaced 700 feet of cast-iron transmission main w/ deficient flow rates

Auburn Ave – replaced 470-ft of asbestos-cement main w/ history of breaks, in collaboration with Town sewer project.

Auburn Ave Extension – 250-ft of cast-iron main w/ history of breaks, in collaboration with Town sewer project.

Perkins Ave – replaced 500-ft of asbestos-cement main than was too shallow, in collaboration with Town sewer project.

2014 Ocean Boulevard – replace 2,100 feet of very old cast-iron main w/ history of breaks

Great Boars Head – replace 700-ft of very old cast-iron main w/ extremely poor access

2015 Ross Ave – replace 950-ft or cast-iron and asbestos-cement pipe that is too shallow

Gentian / Green / Meadow Pond – replace 1,600-ft of asbestos-cement main that is too shallow

2016 Ocean Boulevard – replace 3,400 feet of very old cast-iron main

**Water Infrastructure and Conservation Act (WICA) Capital Projects
from Aquarion Water Company**

Aquarion Water Company of New Hampshire, Inc. is a regulated public utility as defined by RSA 362:2 and 362:4 and provides water service to approximately 8,700 customers in the towns of Hampton, North Hampton, and Rye.

Beginning in April 2009, Aquarion Water Company customers began to see a new line on their water bills: a small surcharge in accordance with the Water Infrastructure and Conservation Act (WICA). This Act was designed to facilitate more timely replacements of aging infrastructure, such as old or problematic water mains, valves that manage the flow of water through the mains, Aquarion-owned fire hydrants, meters and leak-detection equipment. WICA capital improvement projects are scheduled in Hampton, Rye, and North Hampton.

WICA projects do not require appropriations from warrant articles or Town funds; they are funded through surcharges in your water bills.

With the inclusion of scheduled WICA projects in the Town's CIP report we can better coordinate planned Town infrastructure improvements with planned Aquarion WICA projects. This is especially important for the planning of improvements to Town roads.

The North Hampton Water Commission and Aquarion Water meet quarterly for regular meetings. WICA projects will be updated in the 3rd or 4th quarter annually.

Schedule A is the list of completed WICA projects within each Town from 2010 – 2013 with associated costs, plus proposed projects within each Town from 2014 – 2016 with associated costs.
