The purpose of this Article is to protect Conservation Land by respecting the intent of grantors thereof, if any, and the interests of the citizens of North Hampton.

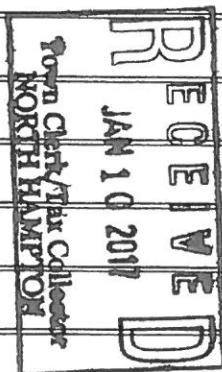
On petition of 25 registered voters of North Hampton, shall North Hampton vote that any development of or changes to any Conservation Land owned or controlled by North Hampton or otherwise designated by North Hampton as Conservation Land be subject to all of the following provisions:

1. said development or changes shall be reviewed by a Review Board for ultimate approval;	5. all meetings shall be open to the public allowing public participation and be broadcast live on Channel 22, recorded and preserved as required by statute;
2. said Review Board shall consist of 1 member from each of the Planning Board, Zoning Board of Adjustment, and Conservation Commission as well as 1 member from the Select Board and the Building Inspector;	6. all meetings minutes shall be taken by a duly appointed secretary and be available for public review within 5 business days of the meeting;
3. notices of all Review Board meetings shall be posted at the Town Offices, the Town Clerk's office, the Town Hall, the Town Library and the Town website, and sent by US Registered Mail to all abutters to the Conservation Land, at least 5 days before said meeting;	7. there shall be no closed door meetings, private understandings or private deliberations;
4. said notices shall describe the development or changes and the Conservation Land by its location, commonly known address or name as well as its tax map designation;


